#### Gender-Neutral Language

When the terms male, female, girls, boys, men, women, mother, or maternal are used, they refer to sex assigned at birth, unless otherwise noted. We acknowledge that gender-diverse individuals may have different preferred terminology, experiences, and needs.

#### Breastfeeding and Infants Born to Gender-Diverse Families

Infants and children of gender-diverse parents may have less access to human milk because of both social and biological constraints. Breastfeeding is used throughout this book; however, the word "breastfeeding" itself may not be the preferred terminology for gender-diverse parents, who may prefer the term "chestfeeding," which is more inclusive of lactation in the context of varying physiologic anatomies, or other terminology.
